UCL Institute for Global Prosperity – Researcher Assistant /Data analyst (2015 - 2016)

Working for the **Institute for Global Prosperity** (2015-2016) my main responsibilities were to review national and international publications, to extract data at the granular/national level from the ONS (CENSUS, NOMIS, NeSS) combined with Ordnance Survey Databases (CASALab, DIGIMAPs), and to design the research methodology for a study focused on East London (involving local community scientists and using Fieldtrip-EDINA app. I also undertook quantitative and qualitative data analysis (in R, SPSS, and NVivo), statistical spatial analysis (using ArcGIS and ESRI products), and prepared reports and story maps to disseminate the research results to peers and institutional partners.

UCL Bartlett School of Architecture – Research Assistant (2010 - 2013)

Between 2010 and 2013, I was involved in the program “**Healthy Cities**” **Lancet Commission Report**, a project coordinated by **Yvonne Rydin, Professor of Planning, Environment and Public Policies at The Bartlett**, and commissioned by UCL Grand Challenge of Sustainable Cities. My work consisted of desk research using online and library resources, identifying relevant web-based readings, developing case studies, creating databases, and **analysing and visualising data**. I was fascinated by the story of the Zabbaleen in Cairo, shocked by the practice of open defecation in the slum of Dharavi, Mumbai, and impressed by the symbiosis between smart cities and urban agriculture.

Policy Studies Institute – Social Researcher (2009- 2010)

While working for the PSI, I have conducted in-depth interviews with migrant workers who had recently entered the UK Welfare system. I translated, transcribed, stored, coded, and analysed the interview data in NVivo, delivering the final report.

University College London - Marie Curie Fellow /European Union Scholarship (2007- 2009)

My research focused on the informal networks that arise among migrants to organise and manage the challenges faced by countries that need their labour but refuse to acknowledge it publicly or institutionalise it openly. I have conducted **extensive qualitative fieldwork in illegal migrant camps** in Spain, Italy and France, and contributed to the documentary film “*Migrant Birds*” (<https://youtu.be/aaNOLaV-FDE>) (UCL Grant).

As a **TA Lead in Business Intelligence**, I managed a team of six TAs, overseeing seminars, assessments, and the marking process. Using Tableau, I supervise and assist students in querying and combining large datasets, as well as in gathering, preparing, and transforming data.

As a Guest Teacher in **Social Network Analysis**, I conducted weekly seminars for postgraduate students, helping them understand key social network analysis concepts and visualise them in R (including centrality, homophily, community measurements, random graphs, network formation, and ERGM analysis).

As a TA in **Statistics**, I have supported students in applying statistical modelling and coding in R (including correlation, parametric and non-parametric tests, and regressions). As a tutor in Methodology, I have been asked to deliver introductory sessions on NVivo, focusing on manual and automatic coding/indexing, efficient metadata storage, and capturing/analysing online data (web pages and social media).
